Tracking Fee for Non-ASCA Dogs: All non-ASCA registered dogs will be required to have an ASCA Tracking Number. This is a one-time fee of \$10.00 per dog. At the time of applying for the tracking number, the individual owner must also be an ASCA member (Service member fee \$10.00). ASCA membership does not need to be maintained in subsequent years. You will be able to apply for a tracking number the day of the show, if your dog does not have one.

If your dog has not earned any ASCA titles, your dog is required to begin in Novice.

ASCA title requires 3 qualifying scores under 2 judges.

Entry Information:

PRE-ENTRIES open April 20, 2018 and must be postmarked by May 5, 2018. Entries postmarked after May 5th will be charged gate entry.

No refund of entries after pre-entry close date

Entries with missing or incomplete information will be returned and does not constitute an entry.

PLEASE NOTE:

- Entries on official ASCA forms only. ASCA entry forms can be downloaded at: <http://www.asca.org/home/business-office/rules-forms/>
- No entry shall be accepted from a dog or handler disqualified from the ASCA conformation program; a dog or handler disqualified from all ASCA programs; or a person not in good standing with ASCA.
- All Aussies over six (6) months of age may be asked to show proof of ASCA registration. Be prepared to present registration papers on all dogs six (6) months of age or older as of the date of the show.
- All dogs may be asked to show proof of rabies vaccination. In that event, a certificate from a licensed veterinarian is required.
- Any dog that displays viciousness toward people or animals at any time on the show premises will be ejected from the show site for the entire show weekend with no refund of entries.
- Physical abuse of any animal will not be tolerated. Any person on the show site reported to have physically abused an animal will be ejected from the show site for the entire show weekend with no refund of entries, and will be subject to disciplinary action per ASCA rules.
- RRVASC, its Board of Directors, ASCA, its Board of Directors, and the property owner assume no responsibility for any loss, damage or injury sustained by exhibitors, handlers or to any of their dogs, personal property and/or children. It is distinctly understood that every dog at this event is in the care and control of its owner or handler during the entire time the dog is on the show premises.
- Participation is a privilege afforded by the Host club and may be extended or withdrawn by the Host club's trial committee on suitable cause only. Refusal of such entries will be reported to ASCA.
- There will be no refunds in the event that a dog and or handler are dismissed from competition, regardless of the reason.
- A 100% refund will be given for any request received prior to the closing date. **NO REFUNDS AFTER CLOSING DATE.** Checks not honored by the bank do not constitute a valid entry fee. There will be a \$35.00 service charge for bank returned checks.
- Pursuant to ASCA rules, any dog displaying clinical symptoms of a communicable disease will be removed from the trial site, with no refund of entries. In the case of removal of a dog that shows symptoms of any contagious disease, all dogs in the same household or traveling with said dog shall also be removed.
- Children under the age of 18 are required to have a parent/guardian present at all times.
- Training on the grounds is prohibited.
- Dogs must be on leash at all times.
- No puppies less than 8 weeks of age are allowed on the show site. Absolutely no puppy sales allowed on the show grounds.

- Anyone caught not cleaning up after their dog (indoors or out) is subject to ejection from the show site, no refund of entries. Please keep your grooming/crating area neat.
- No ex pens or chalking in the building.
- Soft-sided crates limited to two. Please stack crates wherever possible.
- Do not leave unattended dogs on grooming tables.

Building will open at 7:30 AM each day and will close one hour after conclusion of show

DIRECTIONS:

From I-94 (east or west) exit #275 (Cty Hwy F, Sullivan/Ixonia, about 6 miles west of Oconomowoc). Go North on Cty F for about 4 miles. Before railroad tracks, turn left onto Cty P (Elmwood Drive) and proceed to Cedar Dr., turn right and go to end of road to WWCDTC.

From the East take Hwy 16 (out of Oconomowoc about 5 miles west). Turn left/south onto Hwy F. After railroad tracks, turn right onto Elmwood to Cedar Dr.
